VOTING OPERATIONS

Students will be able to vote from 9:00 to 19:00 on 24 November 2020 and from 9:00 to 15:00 on 25 November 2020 using the *U-Vote-on line* instrument.

Each elector may vote using the *devices* available to him/her (PC/tablet/smartphone). The electoral lists that have been accepted are as follows:

BALLOT OPERATIONS

Ballot operations shall commence on 25 November 2020 once voting has concluded, and shall be performed electronically using the U–Vote software under the supervision of the Central Electoral Office. Results shall be announced within six working days via publication in the University's official register and on the University's website on the page https://web.unipv.it/ateneo/elezioni-studentesche-20-22/.

THE ELECTORATE

With reference to academic year 2020/2021 the right to vote is granted:

- a) for the election of representatives in the University's governing board, Regional committee for the right to study, Committee for university sport: to all students enrolled in bachelor's degree, master's degree and PhD courses;
- b) for the election of representatives in the Academic Senate: to all students enrolled in bachelor's degree, master's degree and PhD courses, broken down by the relevant electoral college;

- c) for the election of representatives in the EDiSU governing board: to all students enrolled in bachelor's degree, master's degree and PhD courses;
- d) for the election of representatives in the Evaluation Group: to all students entitled to vote for the Academic Senate for each of the two identified electoral colleges;
- e) for the election of representatives in Department Councils: to all students enrolled in relevant academic programmes;
- f) for the election of representatives in Teaching Councils: to all students enrolled in relevant academic programmes;

Voting is open to those students who have completed enrolment to academic year 2020/2021 at least 25 days prior to the date on which the elections are held, meaning those who have paid the first contribution instalment.

The electorate is extended to students who, on the date of the elections, are correctly enrolled in the final year of a University course (bachelor's, master's degree, including one-cycle courses, PhD) in the academic year 2019/2020, and who have not enrolled for the academic year 2020/2021, as they plan to complete their studies by 30 April 2021; of these students, all those that have paid all contribution instalments for the academic year 2019/2020 at least twenty-five days before the date on which elections are held are entitled to vote.

ELECTIONEERING

With regard to electioneering, posters, printouts or other means of canvassing is permitted only in the spaces made available by the University administration, pursuant to art. 9 of D.R. no. 2340/2020 (https://web.unipv.it/wp-content/uploads/2020/08/Decreto-elez.-stud-firmato.pdf).

The allocation of spaces for election advertising on the University's premises must be authorised in advance by the Rector. The Rector's authorisation shall indicate the places and times for which the requested initiative is authorised, and will be communicated on the University's website on the page https://web.unipv.it/ateneo/elezioni-studentesche-20-22/.

On the day prior to voting and on voting days, rallies, direct or indirect electioneering, putting up of new printed matter, murals or election posters are forbidden in university spaces.

The election campaign therefore ends

at 24:00 on 22 November 2020.

Students that fail to comply with these rules shall be reported to the competent academic authority and face possible disciplinary measures, in accordance with existing provisions, in particular the Rules for Students.

Electioneering shall be performed in full compliance with health rules in place to deal with the current epidemic.
