| | Permit they are in fact required to be in possession of a private |
| | Health Insurance for the entire duration of their stay in Italy. Once in |

F) PRACTICAL INFORMATION

POLICE PROCEDURES

All visiting students coming to Pavia and remain longer than three months **must register with the immigration authorities** as soon as they have an address in Pavia. **Non EU Citizens** are required to apply for a study visa prior to leaving. Applications should be made at their nearest Italian Embassy or Consulate. In this case, they might need a letter of acceptance to ask for their visa Students are invited to start these procedures well in advance their planned visit to Italy. These procedures are subject to change so it is worthwhile telephoning the embassy or checking the website for information before going personally to the visa office. Once you arrive in Pavia you must report to the immigration authorities **within 8 days**. You should go to the:

where you can get all the necessary information regarding the permit of stay application. It will take several months to get the Permit of stay, but the students will be given a temporary voucher issued by the authorities with the same value of the Permit of stay.
