### DECLARES

to have read the safety and health protection measures in the dedicated section of the institutional website of the university and to adopt, during the admission test, all the containment measures necessary to prevent the contagion from COVID-19

not to be subjected to the measure of quarantine or trustee home isolation and / or the prohibition of removal from one's home provided as measures to prevent the spread of the COVID-19 contagion pursuant the current legislation

not having or having had symptoms (e.g., fever, sore throat, cold, nausea, chills, headache, cough, diarrhea, vomiting) attributable to COVID-19 in the previous 14 days

to have been tested positive for COVID-19 and undertaken an isolation period of at least 10 days from the onset of symptoms (not considering anosmia and ageusia / dysgeusia - loss or alteration of taste and smell - which may have prolonged persistence over time) accompanied by a molecular test with negative result, performed after at least 3 days without symptoms

to have been asymptomatic positive for COVID-19 and undertaken an isolation period of at least 10 days from the onset of positivity, at the end of which a molecular test is performed with a negative result

In case of close contact with COVID-19 positive people:

to have undertaken a mandatory quarantine period of 14 days from the last exposure to the case

to have undertaken a quarantine period of 10 days from the last exposure with a negative antigen or molecular test, carried out on the tenth day

not to have been in contact with COVID-19 positive people, to the best of their knowledge, in the last 14 days
